He indicated that virtually all of the attendees at Grievance Day had legitimate concerns. He further indicated that there were many more complaints than usual. Most years there are few complaints, and many are unfounded. This year however, they were much more legitimate and that Mr. Galarneau's reaction to many of the attendees was unprofessional.

- 5. **Supervisor's Report** Supervisor opened his report with a listing of the many goals and issues that should be addressed in 2024
 - A. Goals for 2024: Bicentennial, website, Town Hall renovations, accounting, storm recovery, road shoulders, Rita Wilson playground, Standish playground, bathhouse renovations, ballfield improvements, etc. We are still looking for volunteers to help with

the Bicentennial events. Town Hall renovations are being done to the kitchen, new cabinets, flooring, dry wall, painting and counter tops. Future plans are to replace all the carpets and some ceiling work. Still have issues with accounting, road shoulders need work. The Saranac Legion is looking into buying a swing set for the Rita Wilson playground, discussion was held regarding the Standish playground. Ballfield improvements include a fence, clay for bases and foul poles.

- B. Cleaner Position Supervisor indicated there has not been a cleaner for some time.
